

Student Assistance Program Liaison Contacts for Cyber Schools

Purpose

The PA Network for Student Assistance Services (PNSAS) developed this list of Student Assistance Program (SAP) Liaison contacts in each county to assist cyber schools in connecting PA students with mental health and/or substance use concerns to local county resources. Cyber school SAP teams who have identified students with mental health and/or substance use concerns can reach out to the SAP liaison contact in the county where the student lives, and that contact will help to connect the student to local services and provide contact information for and referrals to local services.

Information Provided

- Some counties have a single agency to serve as a contact for students with both mental health and substance use concerns. For those counties, you will find a “behavioral health” contact rather than two separate mental health and substance use contacts.
- Some counties have identified multiple liaison contacts to serve certain geographical areas within the county. Cyber schools should reach out to the contact in the area where the student resides.
- Some liaison agencies may be able to provide additional services beyond referral/connection to local services. Those possible services are outlined under “additional services provided.” There may be a cost associated with some of the services. Reach out to the liaison contact for information about the cost of any additional services.
- Where a primary and secondary contact for a liaison agency have been provided, cyber schools should reach out first to the primary contact.

Please note: The information in this document is only up to date as of revision date below and therefore could have changed. This list of contacts will be updated annually. If you are having trouble reaching a county’s contacts, you can contact the PNSAS Regional Coordinator that covers the county.
