### Act 44 Resources from PA Department of Education: Office for Safe Schools

On June 22, 2018, The Pennsylvania Public School Code of 1949 was amended via Act 44 of 2018 (Act 44). This law specifically requires school entities to:

- 1. Appoint School Safety and Security Coordinators;
- 2. Establish mandatory school safety training for school entity employees, and
- 3. Establish standards for school police, school resource officers, and school security guards.

Act 44 also created the School Safety and Security Committee within the Pennsylvania Commission on Crime and Delinquency (PCCD), and established the Safe2Say Program in the Attorney General's Office.

Act 44 further requires the development of school safety and security assessment criteria. PCCD established a School Safety and Security Committee and developed a guide with specific school safety and assessment criteria.

# Act 18 of 2019

Recent amendments by Act 18 of 2019 and Act 67 of 2019 included the development of a model trauma-informed approach plan; model trainings for threat assessment teams; and set training requirements for school resource officers (SROs), school police officers (SPOs) and school security guards.

# The Intersection Between Suicide Prevention and Firearm Safety

DDAP's State Epidemiological Outcomes Workgroup released a data brief entitled, <u>The Intersection Between Suicide</u> <u>Prevention and Firearm Safety</u>. This brief presents data on suicide (specifically suicide by firearm), highlights risk and protective factors associated with suicide using PA Youth Survey data, and strategies (including SAP) that can be used to help prevent suicide.

# SAP FACTS

We continue our series on the Pennsylvania Student Assistance Program Components and Indicators which focuses on SAP best practices. This month highlights the sixth essential component of SAP practice which is "Intervention and Recommendations". The original handbook can be located on the SAP website by clicking <u>here</u>.

There are four phases of the student assistance process. Identified as phase three is "Intervention and Recommendations" and described by the following:

- The plan is put into action.
- The team assists in linking the student to in-school and/or community-based services and activities.
- The team might recommend a drug and alcohol or mental health screening or assessment.

While all aspects of the SAP process are important, the pivotal action step is intervening with youth that have been referred in order to initiate change. Once information is collected from everyone involved with the student, data based decisions are key to formulating an action plan comprised of various levels of intervention. Central to this is providing continuous support when offering and implementing all recommended school and community interventions. The SAP team member working with a student should monitor how the youth is doing throughout all steps of their plan.

Teams are encouraged to think broadly when determining in-school interventions. A wide range of interventions, from informal connections with school staff to structured school programs should be considered. Teams have a tendency to report limited in-school resources or at least that's their initial thought. What school and district wide activities/clubs/programs, etc. can you utilize to assist students? For example - tutoring, lunch bunch, Title 1, skill-building groups, backpack program, after school programs, check-in, check-out, and on. Take one meeting to brainstorm what's available – the list generated will surprise you! If there are limited options currently available, consider talking with administration about adding them. Some can be free or low cost but just need administrative support. You'll never know unless you ask!

When warranted, interventions can also include community resources and outreach. Teams are usually well versed in services provided by the SAP liaison and provider agency, but what about the broad based approach regarding other community services available that may benefit your SAP referred students? Examples such as: 4-H clubs, girl/boy scouts, library/hospital programs, youth groups, YMCA, etc. New community programs surface often – with your SAP liaisons, brainstorm about what's available in your local area. Keep the ideas generated and resources available in a prominent location for easy access when discussing appropriate interventions for referred students.

To ensure your team is familiar with current SAP services as well as the screening/assessment criteria and process it's helpful to annually review the school/agency SAP letter of agreement. Team operations and student interventions will benefit from this routine dialogue with the liaisons.

Youth often think there's nothing to do in their town. At times SAP teams fall into that same mindset about in-school and community resources, and may miss intervention opportunities. Take the time, think outside the box, and discuss all options available to enrich your intervention toolbox. Your team satisfaction and student success will blossom!

# Reach Out PA: Your Mental Health Matters

Gov. Tom Wolf announced a focused all-agency effort and anti-stigma campaign, 'Reach Out PA: Your Mental Health Matters,' aimed at expanding resources and the state's comprehensive support of mental health and related health care priorities in Pennsylvania. "For those struggling with their mental health, we have one message: your mental health matters and it's okay to reach out for help," Wolf said. "We are stepping up our efforts to ensure every Pennsylvanian can access mental health care and more agencies can respond to the challenges facing Pennsylvanians struggling with their mental health.

# Strengthening Mental Health Care Access

The Pennsylvania Insurance Department (PID) will pursue Mental Health Parity regulations to ensure Pennsylvanians' health insurance coverage provides access to affordable mental health care.

Recent market conduct reviews by the PID found that insurance companies are not adequately meeting federal and state requirements for mental health parity, necessitating stronger state regulations. PID also will release educational tools to help patients better understand their mental health benefits and access services.

The Department of Human Services will take steps to incentivize the integration of physical and behavioral health services to remove barriers to coordinating care and treatment. DHS will create financial incentives to encourage managed care organizations that provide Medical Assistance benefits to create, maintain and continuously improve collaboration between the entities and providers that coordinate and deliver physical health benefits and mental health benefits.

The Department of Health will conduct a review of the current network adequacy process to ensure that consumers enrolled in the Medicaid program and commercial insurance products are able to access mental health care providers when services are necessary and without prohibitive costs.

The departments of Labor & Industry and State will study solutions that address the inadequacy of the mental health workforce across Pennsylvania, including evaluating mental health practitioners across the commonwealth by level of care they provide, the competitiveness of salaries and benefits and barriers of entry to the workforce.

# Combatting Mental Health Stigma

Many Pennsylvanians do not access the mental health care they need or do not reach out for help because they fear having a label or stigma attached to them by their family, friends and community. By raising awareness of the normalcy and importance of mental health care, others will be less fearful of the stigma. Pennsylvania's nationally-recognized response to the opioid and substance use disorder crisis included public engagement and open conversations to combat stigma. The Wolf administration will deploy the practices used by the Department of Drug and Alcohol Programs to lead a similar effort around mental health and mental illness.

The Department of Education will create pathways to increase the number of highly-qualified social workers trained to work in schools. School social workers play a unique role in addressing mental health by providing holistic services and supports in the school setting, such as crisis management, mental health treatment and engaging the school, family and community in enhancing existing student support structures that ensure the success of all students. Pathways will include new certification, among other options, to enhance who can provide social work services in Pennsylvania's schools.

The Department of Education and the Pennsylvania Commission on Crime and Delinquency will evaluate how to ensure every school district can provide a full-time counselor, social worker and nurse, along with increasing more counseling and mental health services at post-secondary institutions.

The Office of Advocacy and Reform will coordinate and expand upon ongoing efforts in the commonwealth to address Adverse Childhood Experiences (ACEs) and implement more trauma-informed approaches in education, health care, the criminal justice system and other government institutions.

# The SHAPE System

The SHAPE System, developed by the <u>National Center for School Mental Health (NCSMH</u>) team at the University of Maryland School of Medicine, is a free, private, web-based portal that offers a virtual workspace for school mental health teams at school, district, and state levels to document, track, and advance quality and sustainability improvement goals as well as assess trauma responsiveness. SHAPE provides reports and resources for school and district teams to improve the quality of school mental health system in 7 domains: Teaming, Needs Assessment & Resource Mapping, Screening, Mental Health Promotion Services & Supports, Early Intervention & Treatment Services & Supports, Funding & Sustainability, and Impact.

In the last year, the MHTTC Network Coordinating Office collaborated with the NCSMH to refine current and develop new resources, tools, and curricula for the SHAPE System that address unique regional and state considerations, including the recently released School Mental Health Quality Assessment and robust Resource Center, in addition to the Screening and Assessment Library with free or low-cost measures for student mental health, school climate, and much more!

You can join SHAPE as an individual or as a member of a school, district and/or state team. Also, district and state leaders can access a dashboard of school and district data unless data sharing is disabled.

# Supporting Student Mental Health: Resources to Prepare Educators

The MHTTC Network and the National Center for School Mental Health at the University Of Maryland School Of Medicine collaborated on an environmental scan and needs assessment of available educator mental health literacy training and resources. ## **Greyhound-Free Ticket Home**

The Greyhound Lines and National Runaway Safeline offers a free ticket home for homeless youth.

For youth between ages 12-21.

To get a ticket, they need to call the hotline number of 1-800-RUNNAWAY.

They must be listed on a runaway report and be willing to return to their families. Also, their family or guardian must be willing to accept them. If the child is under 15 the youth's family member can get a free ticket to them as well. The ticket can only be accessed twice by the youth.

Before the youth returns, the National Runaway Safeline will work with them to develop a plan for their return and to look at local support services needed once they are settled. As the family is reunited, Safeline will follow-up to see if there are any additional services needed.
