SAP Team Maintenance

This year's SAP articles will focus on the resources available on the PA Network for Student Assistance Services (PNSAS) website. PNSAS regularly updates documents and adds additional resources to the site. The SAP Connection articles will review available resources each month to assist SAP teams and other stakeholders.

What is SAP team maintenance and how often should it occur?

Team maintenance includes those activities and interactions designed to promote cooperation and respectful working relationships among SAP team members. Its purpose is to maintain the health of the team and to ensure the quality of the SAP process so that SAP teams effectively work together as a problem-solving group. The best practice is for the school entity to provide time for team maintenance sessions at least once or twice a year. All members including SAP liaisons should attend maintenance activities. For at least one session, it is advisable for the facilitator to be a non-team member, knowledgeable of group dynamics and SAP.

Fidelity to the SAP model is critical to a high functioning team and supporting students. PNSAS has published the [SAP Fidelity Checklist](#) that can help you assess your school entity and team's functioning.

PNSAS has also created [SAP Team Functioning Survey](#) that can be used to gain insight from team members on areas of strength and improvement of your team.

Other maintenance activities may include reviewing your PDE 4092 data, improving MTSS integration or navigating school-based outpatient treatment in your school building. PNSAS has developed documents to assist your team in these areas.


Key details
