Explore the Training Calendar Tab on the PNSAS Website

This year's SAP articles will focus on the resources available on the PA Network for Student Assistance Services (PNSAS) website. PNSAS regularly updates documents and adds additional resources to the site. The SAP Connection articles will review available resources each month to assist SAP teams and other stakeholders.

The Training Calendar

The Training Calendar tab on the PNSAS website is a resource for educators, administrators, and professionals seeking professional development through SAP K-12 trainings. Trainings are offered by PA Approved SAP Training Providers (PASTPs). PASTPs are organizations approved by the Pennsylvania Network for Student Assistance Services (PNSAS) to deliver standardized SAP K-12 training. Currently, there are 23 approved providers located throughout the state. These providers are responsible for delivering high-quality, consistent training in both in-person and virtual formats. On the Training Calendar tab, you'll find a complete list of these providers, PA Approved SAP Training Providers including their addresses and phone numbers, for questions or registration support.

How to Navigate the Training Calendar

The calendar interface is user-friendly and designed to help you quickly find upcoming trainings: Use the left and right arrows beside the displayed month to scroll through different months. All scheduled trainings for the selected month will be listed below in the calendar. Each training entry includes key details such as: training title, provider name, format (in-person or virtual), location, registration link, and cost information.

Clicking on a training entry will open a more detailed view, allowing you to access full registration instructions, contact information, and any special notes.

Training Format and Continuing Education Credits

All PNSAS SAP K-12 trainings follow a standardized curriculum, whether delivered online or in person. Participants who complete the training are eligible to receive Act 48 credit (13 hours) for professional educators or (14 hours) Act 45 credit for school and system leaders. Training costs may vary depending on the provider, so it's important to review the details for each session.

Free Training Opportunities Through PDE Grant

A highlight of the Training Calendar tab is the availability of free SAP K-12 training through a PDE-funded grant. This grant was awarded to 13 PASTP's and is valid through 2026. Thanks to this funding school entities can access SAP K-12 training at no cost. The grant also covers the cost of substitute staff. Details about this opportunity are available in the PDE funded SAP training announcement.

The training tab is updated regularly as PASTPs add SAP trainings. So, check back to see trainings for later in the school year. Also, feel free to contact PASTPs about hosting a local training.

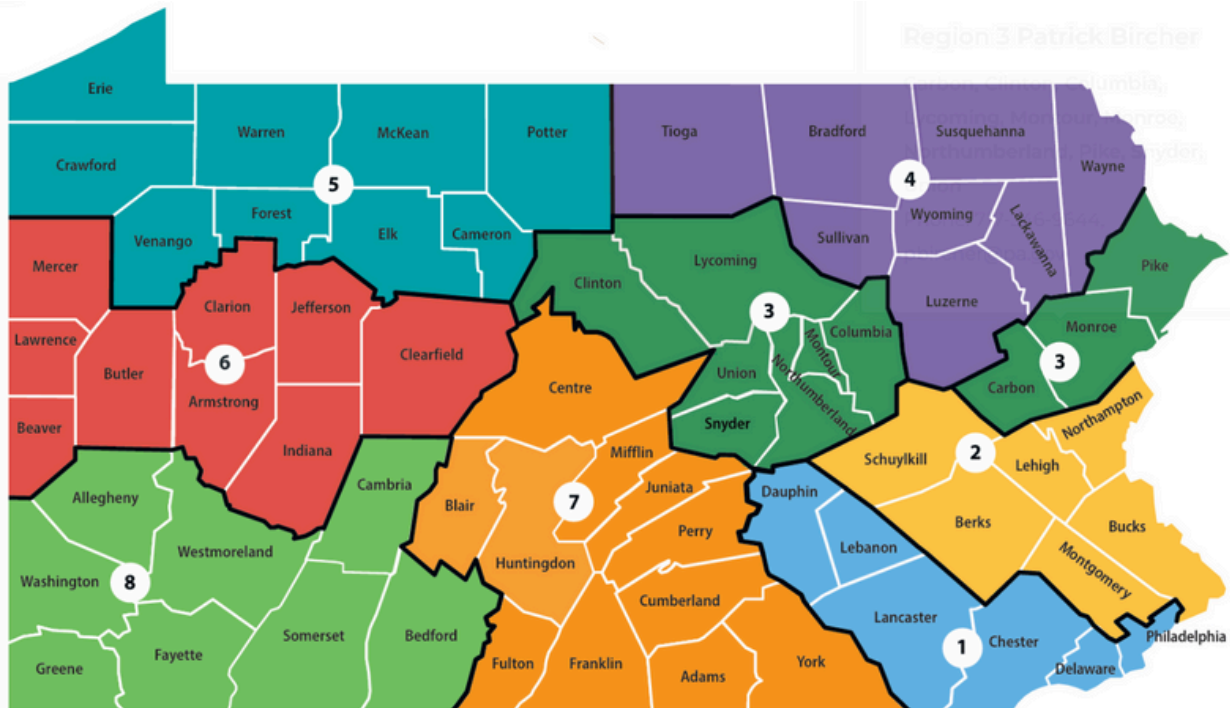
