SAP Teams: SAP Data Reporting-End of year

Each school building should submit their anonymous student referral data (using the SAP 4092 Form) through the [Commonwealth SAP On-Line Reporting System](#) by June 30th, 2025.

Reminder, this system is open and you are able to enter your data now as you wrap up the year. You can start a SAP form with as little as a case number.

Your school and district's yearly SAP data always gives its SAP teams a good, overall picture of school climate and allows the teams to refine their strategies, track progress and make more informed decisions for the following year.

Additionally, SAP data aids school by identifying trends and patterns, allocating resources as appropriate, setting future goals, tailoring interventions, communicating with stakeholders, promoting preventative practices, as well as assessing systematic changes.

Lastly, your school can utilize the SAP reports available on the site to perform comparisons with both statewide and counties of choice. If there is a need above and beyond those tools/reports, reach out to Jay Wasser (c-jwasser@pa.gov) for further assistance.

SAP Liaison Agencies: SAP Data Reporting

Liaisons report their screening/assessment data. Check that the correct staff have login and passwords so you're ready for data entry. Data should be submitted and approved by county agencies by July 31st on the [SAP Liaison Annual Reporting website](#).

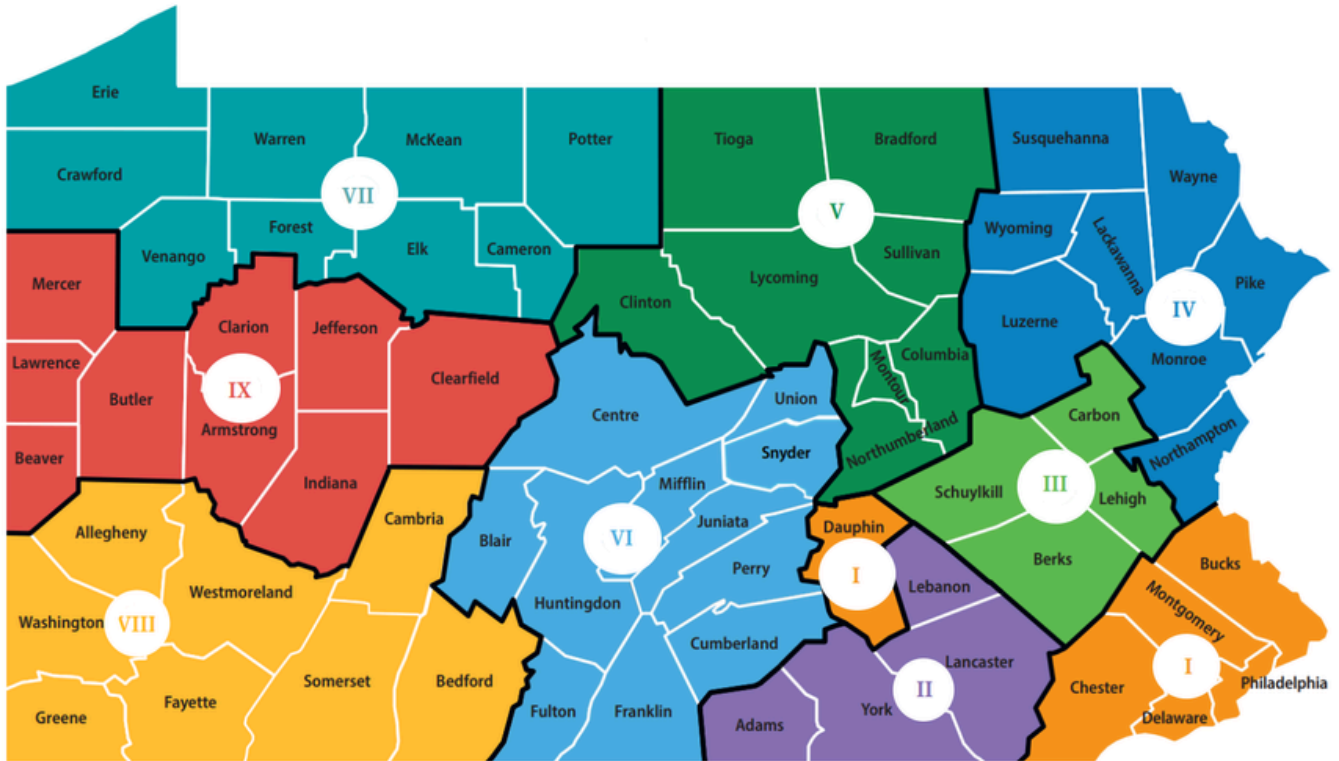
